The Handgun Permit Unit (HPU) and the Administrative Investigation Unit (AIU) both continue to work diligently to process cases in a timely manner. AIU conducts background investigations for handgun permits, security guard, security systems, private detectives, special police, railroad police, and employment applicants for LD potential hires. The AIU strives to complete all background investigations within the 90 day goal set by MSP policy. Currently the AIU has (754) open handgun permit background investigations. The vast majority (98.94%) is completed within the 90 day limit; however, 1.06% (8 cases) have exceeded the 90 day goal. It should be noted all 8 cases that are exceeding our 90 day policy are assigned to investigators and are in various stages of investigation working towards completion. As of 11/3/17 all wear and carry handgun permit renewals are being processed and issued in **less than 60 days**.


