III. **Jurisdiction**

The Court has subject matter jurisdiction over this action seeking a declaratory judgment on the issue of the constitutionality of New York State Penal Law §§ 265.00 and 265.01.

IV. **Claims and Defenses**

Plaintiff:

Plaintiff's claim is that sections 265.00 and 265.01 of the New York Penal Law, to the extent that those statutes define and punish as a crime, the simple possession of nunchaku within one's home, are unconstitutional and of no force and effect by virtue of the Second Amendment's protection of the right to keep "arms."

Defendant:

In addition to the affirmative defenses set forth in Defendant's Answer to the Second Amended Complaint (*see* DE 118), Defendant contends that nunchaku are not commonly used for legitimate purposes and, therefore, are not entitled to protection under the Second Amendment. Defendant argues, in the alternative, should this Court determine that nunchaku are subject to protection under the Second Amendment, that the Penal Law sections at issue herein are rationally related to a legitimate State interest.

V. **Jury or Bench Trial**

The trial will be a continuation of the Bench Trial which was held in January 2017. The parties anticipate proceedings to take one (1) day.

The parties would also consent to presentation of the case in the form of a "trial by papers" whereby each party would submit its arguments in writing.¹

VI. **Consent to Trial by a Magistrate Judge**

This matter is a continuation of the Bench Trial with District Judge Chen presiding.

¹ Hon. Forrest conducted trial in a remanded case "largely on papers" through submission of affirmative arguments through declarations. (*See e.g.* CV-11-3918, SDNY Docket Entry 181 and 197, at pages 3-4). The parties herein would be amenable to proceeding in a similar fashion, should same be acceptable to this Court.
